Application Deadline and Program Completion

The Nursing Leadership - Clinical Operations Certificate Program specialty coursework begins in the fall (August). See application for details.

The certificate programs are approximately 3 to 4 semesters in length if program of studies is followed. The certificate program of study is dependent on the previous graduate course work and courses may be waived or additional courses required. However, all students must successfully complete specialty track coursework, achieve 150 practicum hours and maintain a 3.0 GPA to earn a program certificate.





Mount Carmel College of Nursing's Nursing Education Certificate Program, offered online, prepares the Master's prepared registered nurse to enter the academic classroom and institutional staff development department as faculty to educate the next generation of nurses or to take on staff development responsibilities in a healthcare setting. This advanced professional will apply relevant research in nursing education and understand the ethical and legal issues associated with the role of an educator in nursing. The program will conclude with a practicum learning experience.





1 Determining Financial Aid and Eligibility

The total cost of attending Mount Carmel College of Nursing will vary from year to year. The total cost of attendance includes tuition, fees, and the cost of books, uniforms, transportation and personal expenses. Only tuition and fees are direct expenses, but indirect expenses are calculated into the cost of attendance.

The "Expected Family Contribution" (EFC), is arrived at using a government formula that takes into consideration the following: Parents' and student's total income, or student's and spouse's total income, number of dependents, number in college, and other assets.

A student's eligibility for loans, grants or scholarships is determined by the following formula:

Total Cost of Attending Mount Carmel
Minus (-) Expected Family (Student and parent or spouse) Contribution (EFC)
Equals (=) Eligibility for need-based financial aid

2 Applying For Financial Aid

To be considered for Federal, State, and Institutional grants, loans, and scholarships, a student must submit a Free Application for Federal Student Aid (FAFSA). The Mount Carmel College of Nursing FAFSA code is 030719. Scholarships are available for accepted and confirmed students.

The student may receive requests for further documentation. All requested materials must be returned to the MCCN Office of Financial Aid within 30 days to avoid possible loss of financial aid. The student will receive a financial aid award letter after all forms are complete. A student may file an appeal at any time during the academic year if there is a significant change in his/her family's income. Contact the Office of Financial Aid. The student must resubmit a new FAFSA or renewal FAFSA each year in order to reapply for financial aid for the next academic year. 3 College Payment Plan

 The College Payment Plan allows the student or responsible party the convenience of spreading the tuition and fees expense over a number of months.

Tuition and fees for one semester may be included in the payment plan.

- Pending financial aid is taken into consideration when calculating monthly payments.
- Changes to the payment plan may be made with the approval of the MCCN Bursar.

Tuition and fees can be paid monthly over the duration of a semester with no finance charges or interest. Information regarding this plan is available from the MCCN Bursar Office.

Payment due dates:

Payment is due the Monday prior to the start of the semester. Accounts with balances and no payment plan may be subject to a \$150 late fee.

Payment Methods

Three payment methods are available:

- (1) Payment may be made by check or money order made payable to Mount Carmel College of Nursing. Include on the check or money order the student's name and student ID number. If mailing the payment, address it to:

- (2) Payment may be made in person in the Mount Carmel College of Nursing Business Office on the second floor of Marian Hall. The office is open from 8 a.m. to 4:30 p.m. Monday through Friday, excluding holidays. The office can accept checks, or money orders. Credit card payments are accepted online only.
- (3) Payment may be made by credit or debit card or by electronic check online through the student CARMELink account using the Cashnet option in the Bursar Office and Account Information section. American Express, Discover, Visa and MasterCard are accepted and a merchant processing fee of 2.90% will be assessed to the payor on every credit card payment. There is no processing fee for electronic check (ACH) payments.

Financial Aid

- Financial aid that is approved or pending may be deducted from the bill.
- Federal Stafford and PLUS (parent) loans will be credited to the student's account when they are electronically transmitted (EFT). Student is notified of the receipt of the funds by the Bursar Office.
- Financial aid is credited to them student's account as it is received by the College.
- When a credit balance occurs, the student will receive a refund of that amount.
- If financial aid deadlines are not met, the student is responsible for paying the entire balance due.

Mount Carmel College of Nursing Endowed Scholarships


